**ThriveWell's Deriving Inspiration and Vitality through Activity (DIVA) Program provides exercise, nutrition and wellness classes to breast cancer patients and survivors in San Antonio and Bexar County. Research shows that women who exercise and follow a low-fat diet and adhere to their recommended hormonal or chemotherapy, have a reduction in breast cancer mortality by up to 50%. As of December 31, 2016, the DIVA Program offered 32 classes a week at 5 difference locations across San Antonio. More than 800 women are on the DIVA roster.**

**ThriveWell Cancer Foundation provides patients with financial assistance to help offset the costs associated with their medical care, as well as treatment related transportation. The goal of the program is to give patients the best possible chance of beating the disease while eliminating the added stressors that go hand-in-hand with cancer. During 2016, ThriveWell's Patient Assistance Program provided transportation and financial support to 482 cancer patients.**

**ThriveWell Cancer Foundation funded three cutting-edge research grants in 2016.
