RESEARCH SHOWS THAT WOMEN WHO EXERCISE AND FOLLOW A LOW-FAT DIET AND ADHERE TO THEIR RECOMMENDED HORMONAL OR CHEMOTHERAPY, HAVE A REDUCTION IN BREAST CANCER MORTALITY BY UP TO 50%.
