a. ThriveWell's Diva&Dude program provides exercise, nutrition and wellness classes to cancer patients and survivors in San Antonio and Bexar County. Research shows that women and men who exercise, follow a healthy diet and adhere to their recommended hormonal or chemotherapy, have a reduction in cancer mortality by up to 50%. As of December 31, 2018, the Diva&Dude program offered 35 classes a week at 5 different locations across San Antonio. More than 1,000 women and men are on the Diva&Dude roster.

b. ThriveWell Cancer Foundation provides patients with financial assistance to help offset the costs associated with their medical care, as well as treatment related transportation. The goal of the program is to give patients the best possible chance of beating the disease while eliminating the added stressors that go hand-in-hand with cancer. During 2018, ThriveWell's Patient Assistance Program provided transportation and financial support to 807 cancer patients.

c. ThriveWell Cancer Foundation funded two cutting-edge research grants in 2018. The title of the funded projects is as follows: 1) A pilot, double-blind, placebo controlled randomized controlled trial of exercise=creatine supplementation to augment the adaptations of exercise training in cancer survivors; 2) Preclinical testing of repurposing anti-depressant imipramine to augment triple negative breast cancer treatment.
