ThriveWell's Diva&Dude program provides exercise, nutrition and wellness classes to cancer patients and survivors in San Antonio and Bexar County. Research shows that women and men who exercise, follow a healthy diet and adhere to their recommended hormonal or chemotherapy, have a reduction in cancer mortality by up to 50%. Because of COVID-19 pandemic, the Diva&Dude program classes were virtual during 2020. The online classes had 1,800 views each month, providing a way for cancer patients and survivors to stay healthy and safe.

ThriveWell Cancer Foundation provides patients with financial assistance to help offset the costs associated with their medical care, as well as treatment related transportation and lodging. The goal of the program is to give patients the best possible chance of beating the disease while eliminating the added stressors that go hand-in-hand with cancer. During 2020, ThriveWell's Patient Assistance Program provided transportation, lodging and financial support to more than 1,300 cancer patients.

ThriveWell Cancer Foundation's Board of Directors decided not to fund any research projects in 2020 instead utilizing our resources to meet the overwhelming need for financial assistance during the COVID-19 pandemic.
