DURING 2024 THRIVEWELL'S PATIENT ASSISTANCE PROGRAM PROVIDED LODGING, TRANSPORTATION AND FINANCIAL SUPPORT TO 1,707 CANCER PATIENTS.

RESEARCH SHOWS THAT WOMEN AND MEN WHO EXERCISE, FOLLOW A HEALTHY DIET AND ADHERE TO THEIR RECOMMENDED HORMONAL OR CHEMOTHERAPY, HAVE A REDUCTION IN CANCER MORTALITY BY UP TO 50%.
